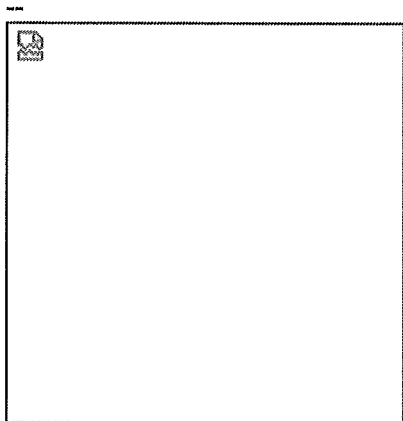

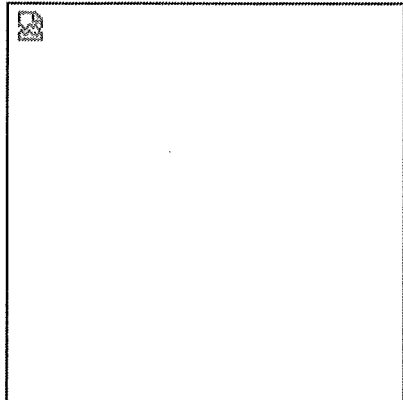

We have received your email and Mr. Robilotti will follow up with you and the Title IX conversation. Until then, if this incident should happen again and [REDACTED] is feeling unsafe or feels as though her privacy has been violated, [REDACTED] should seek out the nearest coach or adult in the building to explain the situation so it can be investigated immediately. We understand you not wanting us to speak to [REDACTED] about any incident that had occurred previously but please know you can always reach out to administration at the high school.

Good Morning,

I am in receipt of the information you have provided and thank you for this feedback.

I wanted to clarify that nowhere in my communications did I discuss, inquire or include language about the rights of the male student, laws that protect him or delve into topics or use language like gender identity, gender expression and the like. It is curious that you redirected the focus of my inquiry, brought these topics up and spoke at length about all of the above and did not keep the focus on my daughter.

Your email response in near totality focused on the male student and what rights he has, ways

that he is protected and ensured safety and privacy, along with a list of state laws that support him. There is almost no mention of [REDACTED] at all.

I am concerned that you are attempting to reframe and shape my inquiry into something that I have never posed to you, nor brought to your attention.

My goal is to discuss and focus on my daughter, her safety, privacy and inquiry related to that. I respectfully request you refocus your attention to the original inquiry about my daughter that I have brought forth.

To clarify, regarding safety, your message stated that applying makeup and walking around a locker room are not unsafe actions. I simply reported to you what was observed and did not state nor imply either act was safe or not. My inquiry related to sharing what has been observed and ensuring [REDACTED] safety and privacy now that this is brought to your attention and moving forward.

I appreciate the invitation in your email to share information that may be relevant to have documented.

I am now, through a third communication, documenting and sharing with you that a male member of the boys track team has entered, and continues to enter, a designated female locker space, as female track athletes, including my daughter, are preparing and changing for track practice. Most recently, on Wednesday, 3/26/25, this took place. You may state that this is an appropriate and safe experience or environment for my daughter, but it does give a parent pause to learn that a male track athlete is present in a female designated locker room as their child and large group of female track athletes prepare and change for track practice.

Additionally, I am documenting that nowhere in your written response on 3/28/25, did you deny that this male track athlete entered the female locker room on 3/26/25, as a large group of female track athletes was present, changing and preparing for track practice. On the contrary, you stated in writing that he is allowed to do so and affirmed that you will continue to allow him to do so, and that my daughter may seek "accommodations," citing New York state laws to support your decision making while ignoring and never mentioning updated federal Title IX policy.

Let it be documented that for a second communication from you, you continue to fail to address my concerns related to updated federal Title IX policy as a federally funded school district. While I appreciate you sharing NYS laws, guidance and more, I also specifically stated in my first email on 3/26/25, that a male was observed in the female locker room as my daughter was present and preparing for track practice.

In my second email on 3/27/25, I stated that Title IX and its recent updates must be taken into consideration in your response to my inquiry.

At no time have you acknowledged or referenced updated federal Title IX policy that vacated and made unlawful previous Title IX policy from 2024 through federal court rule in January 2025. After this federal court ruling, K-12 schools were made aware of the updated federal Title IX policy explicitly in a "Dear Colleague" Enforcement Directive on February 4, 2025.

It is therefore documented that as a federally funded school district, South Colonie Central School District, Colonie High School, and the Athletic Department are choosing to ignore, violate and be non-compliant in following the updated federal Title IX policy, and instead, are choosing to state their

commitment to following New York state laws.

It is further documented that William Behrle, Executive Principal of Colonie High School, William Roemer, Athletic Director of South Colonie Schools, and Dr. David Perry, Superintendent of South Colonie Schools, are the decision makers and/or authors and/or signees and/or senders of written communication on 3/28/25, stating the decision-making in this matter, ignoring of Title IX updated policy via federal court ruling, and intention to follow New York state laws where this matter is concerned.

It is finally documented that [REDACTED] is a female student athlete who is participating in a school sanctioned sport on your campus, using a designated female locker room that is repeatedly having a male boys track team member enter said space while she and other female track athletes are present, changing and making preparations for track practice.

I appreciate the opportunity to ask clarifying questions. Please reply to the following clarifying questions as they will help guide discussion for [REDACTED] and help outline how she will try to remain safe and try to have her privacy protected moving forward:

- Specifically, your communication mentioned accommodations: should a male be present in the female designated locker room, what accommodations for [REDACTED] are available, as suggested? Please provide examples. Does this include that she vacates, as a female, the female designated locker room when a male occupant enters and remains in this space so that her privacy and safety are ensured?
- As this matter is under review, should a male or males enter the female locker room again, what is she to do in that moment/what protocol would you like her to follow, especially if she feels unsafe or that her privacy is violated?
- As a school district, high school and athletic department, is it your position to continue to ignore updated Title IX policy in favor of NY state laws for all students in district, or is this decision making specifically for [REDACTED]?

Moving forward, I have contacted Christopher Robilotti, Title IX Co-Coordinator, to formally file a complaint that the federally funded South Colonie School District/Colonie High School/Athletic Department is ignoring, non-compliant and in violation of updated Title IX policy in favor of New York state laws.

Thank you in advance for answering the clarifying questions posed in a timely manner. When I attempted to ask Mr. Robilotti, on 3/28/25, about some of the above, he was unable to offer any other answers besides, "I don't know," and "I don't have an answer for that."

Please note, I appreciate the respectful, open dialogue and opportunity for sharing of information and asking/answering clarifying questions. It is not my intent now or moving forward to back-and-forth this topic. However, sharing specific information has been important and understanding information fully through inquiry is important. I do not anticipate continued back-and-forth after learning the information from my final questions above as I anticipate I will have all needed information and will be looking to move through appropriate processes with Mr. Robilotti.

While the district does not have a specific policy addressing this situation, New York State law provides clear guidance on gender identity and expression in schools. Specifically:

- The Dignity for All Students Act (DASA): Prohibits discrimination based on gender identity or expression, ensuring all students are treated with dignity and respect.
- The Gender Expression Non-Discrimination Act (GENDA): Protects individuals from discrimination based on gender identity and expression in public spaces, including schools.
- Assembly Bill A5240A: Requires all single-occupancy restrooms to be designated as gender-neutral.

To address your specific questions:

**Does district policy address this concern, and where can parents access it?**

While the district does not have a specific policy on this topic, we follow New York State laws regarding gender identity and expression, which allow students to use facilities that align with their gender identity.

**Is it the stance of the Athletic Department and Colonie High School that males may use the female locker room?**

Per New York State law, students are permitted to use facilities that correspond with their gender identity. The district adheres to these legal protections to ensure an inclusive and supportive environment for all students.

**How is a student's privacy and safety ensured in the locker room?**

We take student privacy concerns very seriously. To support all students, those who prefer additional privacy may request access to alternative changing areas, such as private stalls or the all-gender restroom. We are happy to discuss any accommodations that would help students feel comfortable while ensuring compliance with state regulations.

Additionally, based on the information you provided, the described actions—remaining in the locker room while applying makeup and walking through the space—do not inherently pose a safety threat. However, if there are additional details or if any future interactions are inappropriate in nature, those concerns would be addressed accordingly.

**What is the purpose of the high school's all-gender restroom?**

The all-gender restroom provides an additional option for students who prefer a private space. It is available for use by any student who chooses it.

Good evening,

I am in receipt of your response to my concern and inquiry. It is inept, inappropriate and unacceptable given the privacy and safety concerns that were raised and remain with my daughter.

It is also unhelpful and inappropriate to offer a response 17 hours later with a one sentence, end of business day generic response that neither acknowledges my concern, offers no suggestions, problem solving, answers, nor interim solutions to ensure my daughter's safety, privacy or comfortability within her school campus immediately for today and moving forward, as you take time to, "get back to you as soon as possible with answers to your questions."

It is curious that such a response was received at the very close of the high school day when no response or engagement could take place for active dialogue or discourse between myself and administration.

The lack of response and guidance from all involved allowed my daughter to be unsure of what to expect today while changing in the female locker room, unaware of what to do to help herself should she feel uncomfortable, and unknowing of whom to look to for help with this sensitive topic should it arise again.

It is my understanding that in New York State, guidance, not mandates, has been issued years ago regarding bathroom and locker room use in schools and it is each school district's BOE responsibility to decipher and adopt its bathroom and locker room policies after reviewing the updated guidance and hopefully, after engaging the school community in discussion regarding the topic.

My inability to find such a BOE policy in the link provided on [southcolonieschools.org](http://southcolonieschools.org), coupled with your inability to provide an answer to my simply posed question: "...does district policy address this concern and if so, where is it available in writing for parents to view?" leads me to believe that no such policy exists.

In turn, this leads you to be unable to answer the remaining questions I posed, as well as the purposeful stalling tactic put forward in your communication.

Further, it is also my understanding that updates to Title IX have recently taken place that also must be reviewed and taken into consideration where this matter is concerned.

Due to your lack of serious response or acknowledgement, delay in any help, answers, information sharing, problem solving and more, I have filed a formal complaint above and outside of the school district to help swiftly and seriously address my concern that on more than one occasion, a male has entered the female locker room with multiple young ladies present and witness, including my daughter, and that after reporting this concern to you/administration, you have taken no action nor communicated to me about the safety and privacy of my daughter, other than to offer a perfunctory, thanks for sharing, I'll get back to you type response.

Respectfully, I ask again for a prompt reply to the questions previously posed so that my daughter's privacy and safety is appropriately addressed. To be clear, no one is to speak to my daughter regarding this matter without either of her parents present. We will relay all necessary information to her after hearing from you the requested information.

It is reasonable to request the favor of a response by 1:00 p.m. tomorrow, affording you two business days to answer very simple, straightforward questions.

We are reaching out to you to share our concern about a male entering the female locker room while our daughter, [REDACTED], was present and preparing for outdoor track practice.

It has been brought to our attention that on two separate occasions, the most recent being this afternoon, a male, perceived to be an 11th grader, [REDACTED], has entered the female locker room while females were present and preparing for track practice.

In the first instance, he remained in the locker room for a time, applying make up. Today, he walked around and through the locker room.

It is our understanding that multiple witnesses were present for each occasion with approximately 10 or more females present today.

While I understand this is [REDACTED] perception, we are bringing this serious concern to your attention for immediate review and follow through.

We have taken the time to review all of your information on the [southcolonieschools.org](http://southcolonieschools.org) website, including handbooks available. We are unable to locate policies or protocols the district may have regarding this topic. For this reason, please reply to the following questions:

- In case we have missed locating the information, does district policy address this concern and if so, where is it available in writing for parents to view?

- Is it the stance of the Athletic Department and Colonie High School that males may use the female locker room?
- If males are allowed in the female locker room, how is [REDACTED] privacy and safety guaranteed?
- What is the purpose of the High School's All Gender bathroom?

A prompt response and attention to this matter is appreciated as [REDACTED] will be practicing daily for the remainder of the school year for her sport, and her privacy and safety is very important to us.

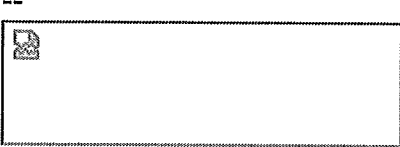
